**LOCATION:** Landreth Park - Joplin, MO

**RATES:** 10' x 10' Outdoor Space - **\$175** - includes 1 electrical receptacle  
10' x 20' Outdoor Space - **\$275** - includes 1 electrical receptacle

**ELECTRICITY:** Each vendor will be provided with one (1) 110v receptacle. Vendors must disclose all electrical equipment that will be used in their booth. If additional power is needed, Festival staff must be notified PRIOR to Festival setup. Additional electrical requirements are subject to approval by the Festival Electrical Team and may result in additional fees.

**LICENSING:** All City of Joplin business licenses, Missouri sales tax licenses and any other fees related to your booth are the sole responsibility of the exhibitor/vendor. City of Joplin vendor licenses may be purchased at Joplin City Hall in the Finance Department or purchased onsite at the Festival during license inspection. City of Joplin vendor licenses are **\$3** per day. Check or money order is accepted. For vendor license information, contact the City of Joplin Finance Dept. at 417-624-0820 ext. 242.

**TENT RENTAL:** All marketplace booths are outdoors, therefore a tent is recommended for all vendors/exhibitors. If vendors/exhibitors need to rent a tent for their booth, they must do so using the Festival's tent provider (see company information below).

**SETUP:** Festival grounds will be open for setup on Wednesday, August 24th from 3:00pm - 8:00pm and Thursday, August 25th from 8:00am - 1:00pm. All vendors/exhibitors must be set up and ready by 1:00pm on August 25th at which time the Boomtown Days committee will do a final walk through. Spaces not occupied and set up by 1:00pm on August 25th will result in forfeiture of the booth space and all fees. No refund will be granted. Security will be provided starting Wednesday at 10:00pm.

All vehicles and trailers MUST be removed from the exhibiting area immediately after unloading and PRIOR to display setup. Parking will be provided for all exhibitor/vendor vehicles in designated area.

**EXHIBITING:** Exhibitors/vendors are responsible for their own tables, backdrops and any other materials they need to make an attractive booth display. All displays must be neat and maintained throughout the duration of the Festival.

Exhibitors/vendors must be present and open during ALL hours of the Festival and may not sublet or apportion space to anyone else. Refunds will not be granted for any reason including inclement weather or cancellation of Boomtown Days Festival.

Exhibitors/vendors shall be liable for delivery, handling, setup and removal of their own displays and materials. Boomtown Days Festival is not responsible for any items left at the site past 1:00pm on August 28th.

**Disclaimer:** NO Exhibitor/vendor may reproduce or create customized Boomtown Day merchandise with the name "Boomtown Days" or any likeness of Boomer without written permission from the Boomtown Days committee. Boomtown Days provides some opportunities for vending, sampling and product promotion or sales. However, certain items such as literature, beverages, water, filled water bottles and T-shirts are prohibited. In addition, vending, sampling and promotion of certain categories is prohibited including: tobacco, vacation/time share packages, religion, politics, sex, liquor, credit cards or firearms. NO items may be made from elephant or whale ivory.
